

# 2018 Gulf Oil Concert Getaway Promotion

## OFFICIAL RULES

**NO PURCHASE NECESSARY. Purchase does not improve chance of winning. Void where prohibited.** The 2018 Gulf Oil Concert Getaway Promotion (the "Promotion") is sponsored only by Gulf Oil Limited Partnership ("Gulf" or "Sponsor"), which has its principal place of business at 80 William Street, Suite 400, Wellesley Hills, MA 02481.

**Eligibility:** Promotion is open to legal U.S. residents who are eighteen (18) years of age or older (except in the case of legal residents of certain states/territories/provinces where the legal age of majority is greater than eighteen (18) years of age, such legal age of majority) at the time of entry. Employees, officers, directors and agents, of Gulf, Live Nation Worldwide, Inc. ("Prize Provider" or "Live Nation"), and each of their respective parent, subsidiaries, affiliates, divisions, agents and advertising agencies, and the Gulf Giving Foundation (collectively, the "**Promotion Providers**"), and their immediate family members (parents, siblings, children, and/or spouses), regardless of where they live, or members of the same household (whether related or not), are not eligible to enter or win any prizes. **Promotional Period:** Promotion begins on April 15, 2018 at 12:01 A.M. (ET) and ends on July 15, 2018 at 11:59 P.M. (ET), the "Promotional Period".

### **How to Enter the Sweepstakes:**

There are two (2) ways to enter the Sweepstakes:

- A) Via the Mobile App: All Users (defined below) of the Gulf Pay mobile application as of the start of the Promotional Period ("Current Gulf Pay Users") will automatically receive one (1) entry into the Promotion. Current Gulf Pay Users may opt-out of the Promotion by emailing [gulfpay@gulfoil.com](mailto:gulfpay@gulfoil.com) and requesting to be withdrawn from the Promotion by June 15, 2018. Persons who are not users of Gulf Pay as of the start of the Promotional Period will automatically receive one (1) entry into the Promotion by downloading the Gulf Pay mobile application to a personal mobile device/tablet through the appropriate app store, creating/setting up a personal Gulf Pay account with promo code CONCERT or SUMMER, and completing a purchase within the application ("User"). Each week throughout the Promotional Period, Users will receive one (1) additional entry for each purchase of eight (8) gallons or more using their Gulf Pay account via the Gulf Pay mobile application at any participating Gulf Oil location. Limit one (1) entry per entrant per week during the Promotional Period regardless of the number of gallons purchased in excess of eight (8). The entrant will be the person named on the Gulf Pay account as long as such person is otherwise eligible in accordance with these Official Rules. Apple, Inc. is not a sponsor of or responsible for conducting the Promotion.
- B) Mail-in: Eligible entrants who do not wish to download or make a purchase using the Gulf Pay mobile application may enter the Promotion by clicking here, printing the entry form,

completing the entry form with all the information requested and sending it by mail to: Concert Getaway Promotion, Gulf Marketing, 80 William Street, Suite 400, Wellesley Hills, MA 02481. Incomplete entries will be disqualified. All mail-in entries must be postmarked by July 14, 2018 and received by July 23, 2018, in order to receive one (1) entry into the Promotion. Limit of one (1) entry per household regardless of method of entry. Duplicate entries received from the same household will be automatically eliminated. Entries become the property of the Sponsor and will not be returned.

**Sweepstakes Drawing and Winner Notification:**

On or about July 25, 2018, one (1) Grand Prize winner will be selected in a random drawing from among all eligible entries received in accordance with the deadlines stated herein.

The random drawing will be conducted by Sponsor whose decisions are final and binding on all aspects of this Promotion. The potential prize winner will be notified by telephone and/or mail and/or e-mail, using contact information provided or collected at the time of entry. Promotion Providers shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate prize winner may be selected.

Grand Prize: One (1) Grand Prize is available. Tickets are subject to availability, venue capacity, artist and age restrictions. Tickets to a particular concert are not guaranteed. Selection of airline, hotel and concert seat locations are solely within Prize Provider's discretion. All other expenses not specifically mentioned herein are solely the winner's responsibility. Prize Provider reserves the right to provide ground transportation in lieu of air transportation if the winner resides within two hundred (200) miles from concert venue. Prize Provider reserves the right to revoke full or partial prize from any winner or winner's guest who it or venue personnel deem may, in its sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, or may bring Prize Provider into disrepute. Winner will be required to provide a credit card to hotel to cover incidentals which are not included in prize package. Concert must be selected at least thirty (30) days in advance of the travel date and is subject to availability and age restrictions. Travel must take place on the day prior to the confirmed concert and return the day following the concert. All travel must be taken no later than December 31, 2018; no alternative travel dates are available. If winner is unable or unwilling to travel on the dates specified, the prize will be forfeited and may be awarded to an alternate winner. All travel subject to availability and restrictions. Winner and travel guests must travel on same itinerary. If winner is a minor in his/her state of residence, the travel guest must be winner's parent or legal guardian.
